## **Policy Agenda Principles**



Connect for Health Colorado is dedicated to *increasing access, affordability, and choice for individuals and small employers purchasing health insurance in Colorado*. Although we were created in 2011 to administer Qualified Health Plans and the premium tax credit for Colorado under the Affordable Care Act, we also embody the "Connector" role envisioned in the 2008 bi-partisan Blue Ribbon Commission on Health Care Reform and embrace the philosophy underlying the Commission's recommendations. With our *2017-2020 Strategic Plan* as the foundation, we diligently explore pioneering solutions that deliver affordable healthcare to our citizens, with thoughtful public policy serving as the bedrock. We continue to innovate and leverage our technology platform as a model for consumer-focused design and user experience.
