**Position Summary:**

Connect for Health Colorado is currently seeking a security analyst. The position is a key member of the security team responsible for safeguarding critical and confidential information. The security analyst will work alongside the privacy and security officer performing multiple functions as part of the security and privacy program. They will regularly interface with internal business leaders, service providers, state and federal partners, and others. This individual will be expected to stay informed of evolving regulations, threats, risks, technology, and recognized best practices.

**Position Responsibilities:**

- **Compliance:** Assist with managing all aspects of a FISMA-based security and privacy program. Review and update security and privacy documentation including system security plans, privacy impact assessments, corrective action plans, security policies and procedures.
  - **Business support:** Perform security and privacy due diligence by interacting with business leaders on various projects and proposing solutions that meet strict compliance and privacy requirements.
  - **Risk:** Perform security and privacy risk assessments on various projects and vendors as required. Assess new security threats and make appropriate recommendations. Review vulnerability scans and work with service providers on remediation.
  - **Evaluate, design, help implement security solutions for transition to a cloud-based environment.** Assess new technologies and work with internal technology team and external service providers to implement.
  - **Evaluate Privacy and Security functions and controls and recommend enhancements or changes.**
  - **Manage information security incidents, coordinate response, investigate privacy complaints.**
